**:: Definitions**

- 1) Hosted Access** is defined in this contract as access to Archivision, Inc. images that have been licensed in perpetuity, paid for by an institution, and where a signed Archivision Site License is on file with Archivision. Access is provided to the Archivision Library in Library Modules only (Base Collection plus sequential Addition Modules that have been licensed).

Note: Hosted Access is a service for Archivision clients and differs from a typical subscription because the images have been licensed and paid for in perpetuity by the institution. Subscription Access is defined as annual access to Archivision images for institutions that have NOT licensed the images in perpetuity. Subscription Access information is not addressed in this document.

- 2) Service Provider** is defined as any sanctioned commercial entity that provides access to licensed Archivision content via Archivision Library Modules on their own server as a service to

clients of Archivision. The Service Provider may charge a set-up fee and may charge for annual access as per the Hosted Access Fee Schedule posted on the Archivision website at the URL given above.

The Service Provider may also provide incentives where you license or have licensed a substantial product or service to keep your access free, as per the terms of your Service Provider stated below in this agreement. There are currently three sanctioned Archivision Library Module Service Providers: 1) Archivision Inc. 2) Luna Imaging, Inc. and 3) Scholars Resource.

#### **.: Common details .:**

##### **Sign up for hosted service at any time**

The service will be “turned on” within 10 to 15 working days of receipt of your set-up fee (if charged), annual access charges (where applicable) and this signed Hosted Access Agreement, unless you are notified otherwise as per mutual agreement.

##### **Annual access fees**

Annual access fees cover the date from when your service was “turned on” until one calendar year has passed from that date (365 days) and subsequent 365 day terms for which you have requested and paid for access. All access fees will be quoted and billed by your chosen Service Provider, namely Scholars Resource, 60 days prior to the end of your 365 day cycle, and will renew automatically for successive 365 day terms, provided that the annual hosted service fees are paid and no notice of change of terms is given by the Service Provider or you. All annual hosted service fees are subject to change with notice on your renewal invoice date.

##### **If your access service is terminated you may re-sign up at any time**

You may at any time re-sign up for any Hosted Access Service currently available. You may need to pay the current set-up fee per campus for each new start request and any access charges that may apply from your new Service Provider.

##### **Receive the content locally at any time**

You may elect to take the Archivision Library modules you have licensed home AT ANY TIME – however, the hosting set-up fee and access fees charged (if applicable) are non-refundable.

Should you wish to transfer the Archivision Digital Library modules you have licensed to your server please contact Archivision at [contact@archivision.com](mailto:contact@archivision.com) and ask them to send you the metadata and all the derivative files on a drive; there is currently a shipping fee of \$75 provided you return the drive to Archivision using their FedEx ground labels within three weeks.

**Please Note:** While every precaution has been made to avoid service interruption Scholar’s Resource Inc. is not responsible nor liable in any manner for any interruption in access to the Archivision Library, for your institution.

##### **Sign up for all Options or Switch Your Hosted Access Service at any time**

You may sign up for one, two or all three current Hosted Service options at one time. You may at any time switch from one Hosted Service option to another, however, any access fees paid are non refundable and non transferable. Please note that new set-up fees and/or new access fees may apply.

##### **Keeping it Current**

As you license new Archivision Library Modules notify us and we will get authorization from Archivision to turn on your new content. We will attach the authorization email from Archivision to this agreement and you should do the same to keep it up to date. No further changes are needed to this agreement.

- By mutual agreement, Archivision Library Modules are only available for purchase directly from Archivision while Scholars Resource is licensed to provide Archivision images in small groups (e.g. academic sets, textbook sets) and as individual images. **Archivision images purchased directly from Scholars Resource are hosted free of charge.** The access fee, for hosting Archivision Library Modules at Scholars Resource, will be reduced by the amount of images purchased directly from Scholars Resource.
