1) Introduction

- (a) Scott Gilchrist B. Arch., M. Arch., holds a library of architectural, landscape, archaeological, historical, art and artistic digital images, videos (collectively the "Images"). When Images are combined with Archivision's extensive, researched metadata within a database delivery system the library is called the Archivision Research Library (the "Library"). The Library is divided into Modules and periodically grows via the addition of new Addition Modules.
- (b) Scott Gilchrist is the photographer for the majority of the Images in the Library. Scott Gilchrist and Archivision Inc. are the owner of all copyrights in the Images.
- (c) Archivision Inc. ("**Archivision**") also administers and enforces copyrights to the Images and grants licenses or subscription access to use the Images on behalf of Scott Gilchrist.

This Agreement sets forth the terms under which the Subscriber my obtain subscription access to the Library and the permitted use and limitations of all Images with such access.

2) Definitions

- (a) "Addition Module(s)" is defined as a Module added to the Library at any time, of which Addition Modules One through Nine, containing roughly 6,000 Images each, are currently available.
- (b) **"Annual Term"** is defined as a one-year period of time for which Subscription has been paid for, which is the default Subscription Term under this Agreement.
- (c) "**Base Module**" is defined as the charter portion of the Library, containing roughly 16,000 lmages.
- (d) "**Image**" is defined as the architectural, landscape, archaeological, historical, art and artistic digital images, videos, and QuickTime VR scenes made available to the Subscriber under this Agreement.
- (e) "Library" is defined as the aggregate of all Images, combined with extensive, researched metadata within a database delivery system made available by Archivision, which currently includes the Base Module as well as Addition Modules One through Nine, for an aggregate total of 72,000 Images (in 2014).
- (f) "License Agreement" is defined as the agreement governing the use of Images, once subject to Ownership by Subscriber, should the Subscriber later switch to a buy model.
- (g) "Licensed User(s)" is defined as but not limited to staff and patrons at the Subscriber library and members of the walk in public that are given access to the Library or any portion thereof by the Subscriber. For clarification staff may include visiting lecturers and educators.
- (h) **"Module(s)"** is defined as specific divisions of the Library, consisting of the Base Module of 16,000 Images and Addition Modules, each of which currently includes approx. 6000 images.
- (i) "Ownership" is defined as the right to host, download with user limitations, make copies of, and generally use the images for the personal use of the Subscriber and its Licensed Users (with limitations) in perpetuity, but shall not include the right to sell, rent, alter or share (other than with the Licensed Users) the Images or any other similar action, including those actions specifically prohibited under paragraph 3h) of this Agreement.
- (j) **"Rental Fee"** is defined as the fee Archivision charges to a Subscriber for rental access to the Library for one year's use by the Subscriber and its Licensed Users, included in the Subscription Fee along with the Service Provider Fee.

- (k) "Service Provider(s)" is defined as any sanctioned commercial entity, currently including vrcHost LLC and Luna Imaging Inc., which provides subscription access to the Library via this Agreement and on its own server using their database and interface. The Service Provider will load new Addition Modules, as and when such Addition Modules are made available by Archivision, as well as make annual updates to Images and data supplied by Archivision, when made available.
- (I) "Service Provider Fee" is defined as a separate fee a third party Service Provider sets and charges for providing access and use of their server and database interface for the Archivision Simply Subscribe service. The Service Provider Fee is built into the Simply Subscribe Fee.
- (m) "Site License" is defined as a separate license for the Ownership of the Library or of certain Modules. A Site License must be signed and a one time fee paid before ownership of images is granted.
- (n) "Subscriber" is defined as _____(library /consortium name)
- (o) "Simply Subscribe" is defined as rental access via Annual Terms or other Subscription Terms to the Library on a remote server, whether some or all Modules have been licensed in perpetuity and paid for by the Subscriber or not, and where this Agreement is on file with Archivision.
- (p) "Simply Subscribe Fee" is defined as the combination of the Rental Fee and the Service Provider Fee, invoiced directly to the Subscriber by Archivision. Archivision will invoice you for this single fee and pay any third party Service Provider their portion of the fee.
- (q) **"Subscription Term"** is defined as the period of time for which Simply Subscribe has been paid for, as mutually agreed upon in writing by the parties, it being understood and agreed that the minimum subscription term shall be the Annual Term.
- (r) "Hosting Fee" is a fee Archivision will charge in addition to the Simply Subscribe Fee to accommodate access to and the downloading of the images you own as full files at 3100 pixels where both content will be made available together in MDID3. This fee is included in your Archivision quote for Simply Subscribe for one year; hosting of content you own will continue in the annual fee for Simply Subscribe. Should you cancel your Simply Subscribe service the fee for hosting of content you own will revert to vrcHost and you will need to contract directly with them for continued hosting services should you wish to continue the service.
- (s) "Term End Date" is defined as the date the Subscription Term paid for ends.
- (t) "Term Start Date" is defined as the day the Subscription Term starts, being the date on which this Agreement is countersigned by Archivision, unless another date is mutually agreed upon in writing by the parties. Archivision will countersign this agreement the date the Service Provider turns on access for the Subscriber.

3) Terms and conditions

(a) Activation of Simply Subscribe

Simply Subscribe will be activated by vrcHost, your chosen Service Provider, upon receipt of 1) your PO or payment to Archivision as per an invoice addressed to you from Archivision for your Subscription Term and 2) a signed copy of this Agreement, which Archivision will counter sign and return to you, unless you are notified otherwise as per mutual agreement. Annual Subscription Fees paid cover the date from when this Agreement was countersigned and dated by Archivision until one calendar year has passed from that date and subsequent Annual Terms for which you have requested and paid for access and where no notice of change of terms is given by the Service Provider or you.

(b) Cancellation

You may at any time cancel your Simply Subscribe service. However, any Subscription Fees or Hosting

(c) Ownership right

The Simply Subscription service does not grant ownership of Archivision Modules or images or content over time. Ownership is only made available via our Subscribe To Own product and is not addressed in this document.

(d) Ownership option

Any client of Simply Subscribe may switch to an ownership model at any time. You can start with the Base Module and any combination of Addition Modules you wish (in sequence only). Ask us for details. However, no fees paid for the Simply Subscribe product will be applied to the purchase fee; however, we do quote deep discounts to encourage ownership of our Library upon request.

(e) Term, Renewal and Termination

This Agreement shall be for an Annual Term, commencing upon the date written below which is the date of signature unless Subscriber has requested a longer Subscription Term. You may renew your Subscription for a similar Term by paying your renewal Subscription Fee 60 days before your then current Subscription Term expires. We will terminate access with a final 30-day if no payment is received within 30 days from such final notice. Your subscription fee paid is guaranteed to remain the same rate for THREE consecutive years at a time. A revised Simply Subscription annual fee will be provided 60 days prior to the end of this THREE-YEAR sequential term UNLESS no change in the Simply Subscribe Fee is forthcoming.

Upon cancellation of your Subscription, either by written statement to Archivision by you or nonpayment of your renewal Subscription Fee, your access to the Library will be automatically terminated, and you agree to give up the right for further use of the Images in your possession. You will destroy all Images copied on your servers or elsewhere, with the exception of Images for which Ownership was already granted via a signed Site License, if any. After a period of 60 days from the date you were notified of termination Archivision might request a written statement certifying that all copied Images have been destroyed. It is suggested that the Subscriber notify all Licensed Users that its Subscription has been or will soon terminate.

(f) Copyright

Archivision retains full copyright in all Images accessed and/or downloaded by the Subscriber and/or its Licensed Users, even should Ownership of Modules be granted to the Subscriber via a Site License. All Images are protected under international copyright law and other applicable intellectual and proprietary information laws.

(g) Permissible use

Images accessed via Subscription include the following size limitations based on user type: staff via individual staff accounts may download the largest file available (up to 3,100 pixel image if owned, up to 1,500 pixel image if not); patrons & walk in public may download up to 1024 pixel images. The largest file available will be made available for online viewing for study by all Subscribers. Images available for downloaded may be used exclusively for educational, research and personal use, on a not-for-profit basis only, e.g. in lectures, classroom seminars, student papers, assignments, presentations, theses and report covers and, provided that the Images be used for such purposes only, Subscriber and Licensed Users may download the maximum image permissible and print or duplicate and use Images, including use in conjunction with presentation software, e.g., PowerPoint, and in an online or off-line environment. An Image or collection of downloaded Images may also be (i) placed on a web page for classroom study or (ii) placed into Electronic Classroom Management Systems, such as Blackboard, so long as access to that page is restricted to Licensed Users only, including but not limited to, through the

use of a password. Reasonable numbers of Images may be placed into electronic reserves for specific courses of instruction offered by the Subscriber, where access is restricted to Licensed Users, and such access is limited to the duration of the course. In all cases any permitted use of the Images is limited to your Subscription Term.

(h) Prohibited use

Neither the Subscriber nor its Licensed User will:

(i) Rent, lease, publish, time-share or sub-license or in any other way use or authorize the use of any Archivision Image or derivative for profit;

(ii) Use or authorize use of any Image, or any part thereof, as a trademark, logo or service mark;

(iii) Claim any proprietary right of any kind in any Image or derivative;

(iv) Publish, disseminate, or authorize the publication or dissemination of any work or compilation or collective work including books and CD ROMs containing one or more Images or derivatives, where these works are for profit, without written agreement with Archivision, and an additional license fee being paid.

The Subscriber or its Licensed User may acquire other rights, including publication and commercial use rights, via our Royalty-Free website currently found at <u>http://stock.archivision.com/</u>.

(i) Service Liability

While every precaution has been taken to avoid service interruption Archivision nor vrcHost LLC is neither responsible nor liable in any manner for any interruption in access to the Library. Should Archivision need to terminate the access, for any reason, Archivision will, as per Subscriber's written request, 1) offer access with another Service Provider of Subscriber's choice (if available) and 2) transfer the portion of the Subscription Fee paid to Archivision for the outstanding portion of the then current Term to the new Service Provider reducing Service Provider Fee payable by Subscriber to the new Service Provider (if any and if possible). If no other Service Provider is available for such transfer, Archivision shall incur no further liability, and Subscriber shall not be entitled to any refund.

(j) Technical requirements/condition

Use of the Library under this Agreement shall be subject to the technical conditions and requirements set out in Schedule "A", which shall form an integral part of this Agreement. Subscriber shall complete the information set out in Schedule "A" (contact information of hosting administrator/IT specialist).

(k) Choice of law

The parties agree that this agreement shall be governed and construed in accordance with the laws of the COUNTIES of ______(your US Sate or Canadian Province OR UK COUNTY), to the exclusion of its conflict of law provisions.

(I) No Assignment

The Subscriber shall not assign this Agreement or any of its rights and obligations hereunder.

(m) Entirety of the Agreement

The terms and conditions of this Agreement supersede all prior oral and written agreements between the parties and shall constitute the entire agreement between the parties with respect to the matters contained herein. This Agreement shall not be modified or amended except by writing duly executed by
