# **12) YOU MAY NOT:**

- a) Place Images on the World Wide Web, the Internet, or any form of electronic display, such as computer bulletin board or other form of on-line or internet-accessible service, and shall take reasonable steps to make sure the Images are available only to persons who are Authorized Users of the educational institution.
- b) Rent, lease, publish, time-share or sub-license or in any way use or authorize the use of any Image or derivative.

## 21) TERM AND TERMINATION

(a) The License granted under this agreement shall continue in perpetuity following delivery of the Images unless sooner terminated as provided below.

Termination for Breach. If either party believes that the other has materially breached any obligations under this License, such party shall so notify the breaching party in writing. The breaching party shall have sixty (60) days from the receipt of notice to use all reasonable means to cure the alleged breach and to notify the non-breaching party in writing that cure has been effected. If the breach is not cured within the sixty (60) day period, the non-breaching party shall have the right to terminate this License without further notice. Once this License ends, by early termination or otherwise, the Licensor may terminate access to the Licensed Materials by Licensee and Authorized Users, subject to Licensee's Perpetual Access rights. In addition, authorized copies of Images made by Authorized Users may be retained for educational purposes and used subject to the terms of this License.

# 22) WARRANTY AND EXCLUSIVE REMEDY

(a)Archivision warrants that Scott Gilchrist is the owner of copyrights in the Images; and that neither Scott Gilchrist nor Archivision has received, nor is aware of any claim of infringement by a third party with respect to the Images as of the date hereof.

## 23) LIMITATION OF LIABILITY

ARCHIVISION'S LIABILITY TO LICENSEE SHALL IN NO CASE EXCEED THE AMOUNT OF THE LICENSE FEES PAID BY LICENSEE TO VICHOST HEREUNDER. IN NO EVENT SHALL ARCHIVISION BE LIABLE FOR INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES (INCLUDING LOST PROFITS) SUFFERED BY LICENSEE, EVEN IF IT HAS PREVIOUSLY BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

### 24) GRANT OF LICENSE

In exchange for your payment of the License Fees set forth in invoice provided by vrcHOST, Archivision hereby grants to Licensee a non-exclusive, non-transferable perpetual license to install and use the Licensed Materials, and to install and use the associated Archivision metadata, all for education, research and personal purposes only, on all computer systems now or in the future owned or leased by Licensee, or on any authorized third party hosting service.

# 25) GENERAL PROVISIONS

- (a) Assignment. This Agreement may not be assigned by either party or by operation of law to any other person, persons, firms, Universities or corporations without the express written approval of the other party.
- (b) Notices. All notices and demands hereunder shall be in writing and shall be served by personal service or by mail at the address of the receiving party set forth in this Agreement (or at such different address as may be designated by such party by written notice to the other party). All notices or demands by mail shall be by certified or registered mail, return receipt requested, or by nationally recognized private express courier, and shall be deemed complete upon receipt.
- (c) Governing Law. This Agreement shall be governed by and construed in accordance with the substantive laws of the state/province where the Licensee placed the order through the archivision.vrchost.com site.
- (d) All Amendments in Writing. No provisions in either party's purchase orders, or in any other business forms employed by either party will supersede the terms and conditions of this License, and no supplement,

modification, or amendment of this License shall be binding, unless executed in writing by a duly authorized representative of the Licensee.

Entire Agreement. The parties have read this License and agree to be bound by its terms, and further agree that it constitutes the complete and entire agreement of the parties and supersedes all previous communications, oral or written, and all other communications between them relating to the license and the subject matter hereof UNLESS a preexisting Site License exists.

Confidentiality of Personally Identifiable Information. Licensor will notify Licensee and Authorized Users as soon as is practicable if the Licensor's systems are breached and the confidentiality of personally identifiable information is compromised.
